### **General Information**

- All booth spaces are 10 X 10, outdoors, on grass
- Properly weighted down tents are recommended. Staking to the grass is permitted
- Street lights and light towers provide illumination
- Battery-operated lighting recommended
- Limited electrical outlets provided on a first come, first serve basis

### **General Rules**

- THE ONLY GENERATORS ALLOWED are Yamaha EF 2000 i S, Honda EU 1000 i, Honda EU 2000 I. Only federally approved fuel containers will be allowed on premises.
- Submit 3 representative photos of your work to be displayed, along with a photo of your booth. You will be notified of acceptance of your application. Provide **SASE** with this application if you wish your samples to be returned.
- **ONLY** the items described in your application will be permitted to be sold
- **NO PERSONAL CHECKS-NO EXCEPTIONS**
- Payment by Credit Card or *money order* made payable to: Hernando de Soto Historical Society
- Application and payments must be received by March 8, 2019. A \$50 late fee will apply for any applications received after March 8, 2019.
- Refunds will not be issued after March 15, 2019
- No refunds will be given due to adverse weather
